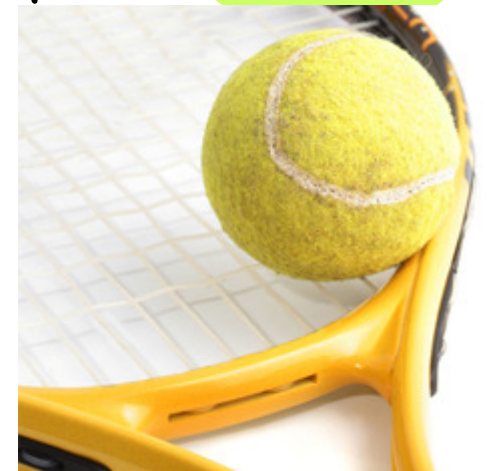

Rules of Play

Tour des Courts is an informal mixed doubles social. Played on private tennis courts throughout Delaware and Pennsylvania. Reservations will be accepted in order of receipt. Entries must be limited due to lack of space. Later entries will be held on a waiting list.

- 1.) Entry fee is \$100 per team (\$60 is tax deductible). Entry fee includes round robin, picnic supper, beer & soft drinks. (\$20 for non playing guests). Make check payable to Delaware Tennis Foundation.
- 2.) Please detach and send part form and check to Tour des Courts, Attn: Jim Fleisch, 800 Carr Road, Wilmington, DE 19809 or register online at www.detennisfoundation.org.
- 3.) Entry deadline is August 30, 2010 after which time money **will not** be refunded. If the event is canceled due to weather, money **will not** be refunded.
- 4.) First and second rounds will be assigned and teams will be notified by email.
- 5.) Each team must bring a new can of tennis balls. Light refreshments will be provided at each location. Bring lunch if desired.
- 6.) Courts will be available for warm-up at 9:00 a.m.
- 7.) Play begins promptly at 9:30 a.m. The first round officially is over at 12:30 p.m. The second round of play begins promptly at 1:30 p.m. and ends at 4:30 p.m.
